Project summary

Water Voles on the Wandle, as part of the Living Wandle project, will guide and improve land management, engage, enthuse and educate the local community in their local patch of river, the wildlife it supports, and the possibility of water voles returning to the Wandle concentrated along a 2km stretch of the river between Watermeads, Poulter Park and Spencer Road Wetlands. The project will have two key strands:

- 1. Surveying, mapping, feasibility study and management plans to prepare this stretch of the river for future re-introduction of water voles this will include offering specialist advice and support to land managers on best practice in managing their section of the Wandle for wildlife value
- 2. Awareness raising and education around water voles on the Wandle a series of walks, talks, open days and events reaching at least 100 people to engage and enthuse the local community and landowners

Why do we want to deliver this project?

The last anecdotal record of water vole on the river Wandle is from 1962 and it is accepted that they became extinct in the catchment soon after. There are plans to reintroduce them when the conditions will be favourable to sustain a viable population; London Wildlife Trust currently leads the London Water Vole Species Action Plan (SAP) whose main aim is to 'conserve London's water vole population and increase their range and numbers for the benefit of current and future generations'. The water vole is Britain's fastest declining native mammal and there is now only one water vole for every twenty that were alive just 100 years ago (a loss of 95%). The water vole is a principal species for nature conservation concern and is a priority Biodiversity Action Plan (BAP) species for the UK BAP, the London BAP, LB Sutton's Rivers and Wetlands Habitat Action Plan (HAP) and LB Merton's Rivers and Streams HAP. This project will work towards targets outlined in the UK and London Water Vole SAP and the London Rivers and Streams HAP.

LWT with partners undertook an assessment of the River Wandle for the reintroduction of water vole in 2009-11. Using this information, a walk from Morden Hall Park to Spencer Road was undertaken with LWT and the Environment Agency in 2016. The consensus is that management of the sites needs to be improved before any reintroduction can begin.

An updated feasibility process needs to be undertaken – we want to use this work as an opportunity to engage new communities in the river and to inspire local people to be part of an exciting potential long-term project to change and improve their local environment. Water voles, immortalised by the character of 'Ratty' in Kenneth Grahame's *Wind in the Willows*, capture people's imaginations and will be the hook to engage at least 100 people from nearby communities in their local patch of river and its potential as a future home to reintroduced water vole populations. By engaging people in this elusive small mammal, we will also be able to inform and enthuse them about the river Wandle as a whole, its history and the important habitat it provides for many other species. The project will also train and engage at least 20 people as volunteers, leading to an even greater depth of knowledge about the river and encouraging new recruits to existing local volunteer groups, meaning this stretch of river can be more sustainably cared for into the future.

Beneficiaries

The main beneficiaries of this project will be people living locally to the three sites and along the target stretch of river, who will be able to volunteer on the project carrying out surveying and feeding into the feasibility study, and who will attend our events programme of guided walks and talks to learn about the river Wandle, their local patch of river, its heritage, the wildlife it is home to and the potential of re-introducing water voles in the future.

Project location

The project will take place along a 2km stretch of the river Wandle between Watermeads, Poulter Park and Spencer Road Wetlands (LB Sutton).

Partnership working

We will work with landowners LB Sutton, LB Merton, National Trust, the Sutton and East Surrey Water Company, KNK Stadium and the Environment Agency to complete this project, working collaboratively to recommend and advise on best practice in river management for the benefit of natural heritage. We have already had positive discussions with the Environment Agency about the need for this work. We will also engage with Registered Social Landlords to promote our events and open days to local people who are residents of social housing.

Main Outputs

- At least 15 events will be delivered as part of the events programme including guided walks, community talks and other events to enthuse and engage people in water voles, their local patch of the river Wandle and how river habitat can be improved for the re-introduction of water voles
- At least 100 local people will be engaged in the events programme above
- Surveys and mapping of the 2km stretch of river will be produced to identify good habitats for Water Vole and the barriers such as concrete river banks, weirs, poor vegetation on banks etc.
- A management plan for this stretch of the Wandle, setting out ways in which the river can be managed for the benefit of future water vole re-introduction, will be produced and shared with landowners
- At least 20 volunteers from the local community will be engaged in carrying out surveying, mapping and inputting into the feasibility study outlined above

Expected Outcomes

- People from the local community will be more interested and engaged in the Wandle and the habitat it provides for wildlife
- People from the local community will have increased awareness and knowledge of water voles and how they could potentially be re-introduced to the Wandle
- Local landowners will increased awareness of how they can better manage their patch of the river for the benefit of all wildlife
- Survey information and mapping carried out during the project will be available online and easier to access for members of the local community
- People from the local community will be more likely to visit their local nature reserve on the Wandle in the future
